Introduction

This Amendment No. 8 to Schedule 13D (this "*Statement*") relates to the beneficial ownership of Common Stock, \$0.001 par value per share (the "*Shares*") of Hudson Global, Inc., formerly known as Hudson Highland Group, Inc., a Delaware corporation (the "*Issuer*"). This Statement is being filed on behalf of the Reporting Persons and amends and supplements the Schedule 13D filed by the Reporting Persons dated April 9, 2012, as heretofore amended. Unless otherwise defined, all capitalized terms used herein shall have the respective meanings given such terms in the initial Schedule 13D.

Item 5. Interest in Securities of the Issuer.

Items 5(a)-(c) are hereby amended and restated in their entirety as follows:

(a) The Shares reported herein are held directly by Sagard. As of March 8, 2016, each Reporting Person beneficially owned 4,650,189 Shares, which represented 13.1% of the outstanding Shares, based upon 35,475,048 Shares outstanding on January 31, 2016, as reflected in the Issuer's Form 10-K filed March 3, 2016. This Amendment No. 8 is being filed because Sagard's percentage of beneficial ownership has decreased by one percent (1%) as a result of an increase in the Shares outstanding, as reflected in such Form 10-K (which Sagard became aware of on March 4, 2016 after such filing became available).

In accordance with Securities and Exchange Commission Release No. 34-39538 (January 12, 1998) (the "*Release*") this filing reflects the securities beneficially owned by PCC and certain of its subsidiaries, including Sagard. The filing does not reflect securities beneficially owned, if any, by any subsidiaries of PCC whose ownership of securities is disaggregated from that of PCC in accordance with the Release.

The beneficial ownership reflected in the remainder of this Item 5, and in the cover pages, reflect beneficial ownership as of March 8, 2016.
