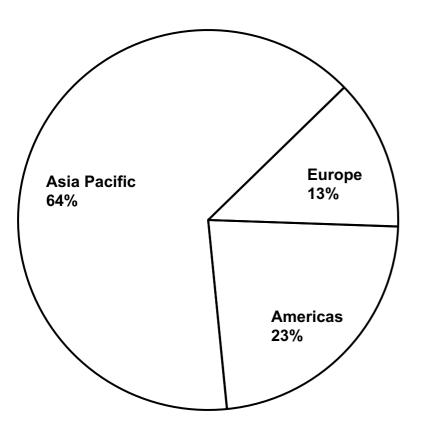

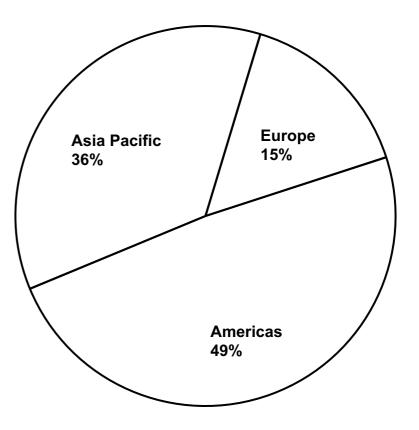

Q4 2021 Regional Split

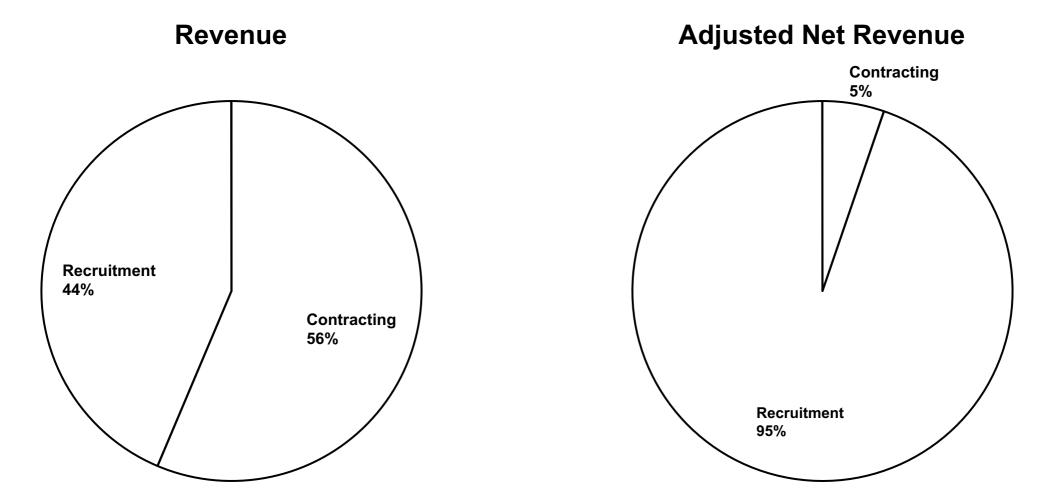
Revenue
