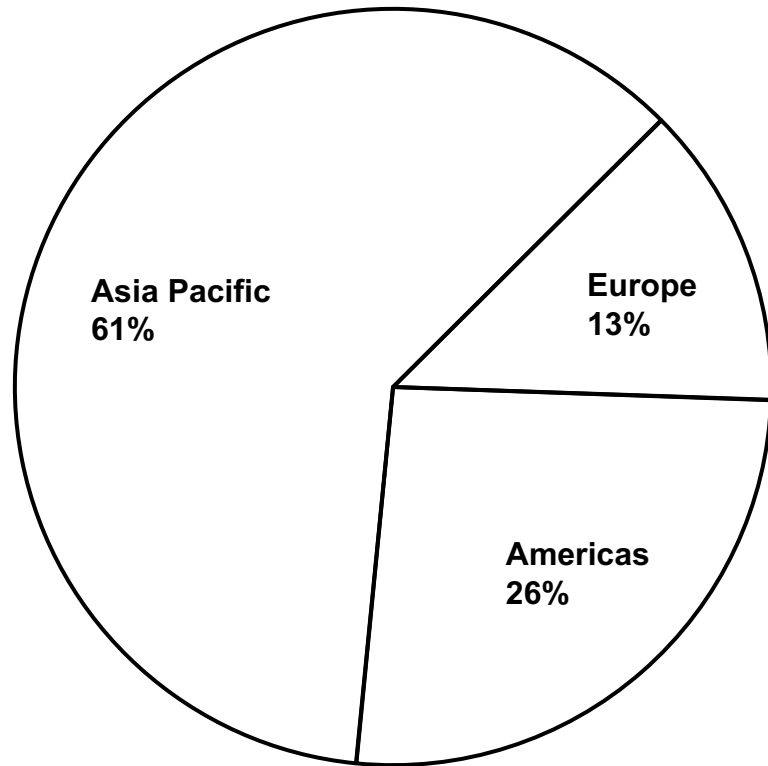

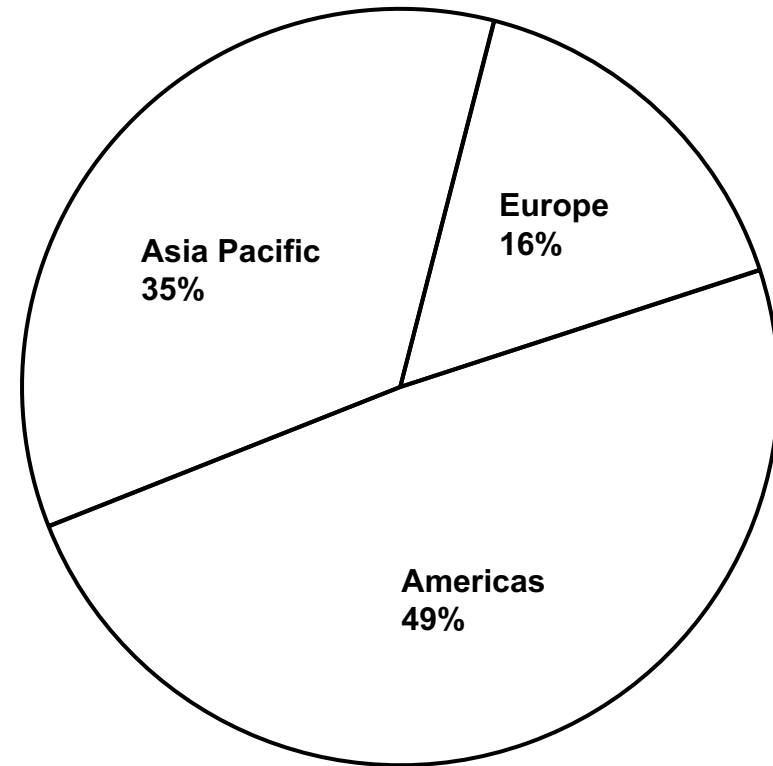

**Revenue**

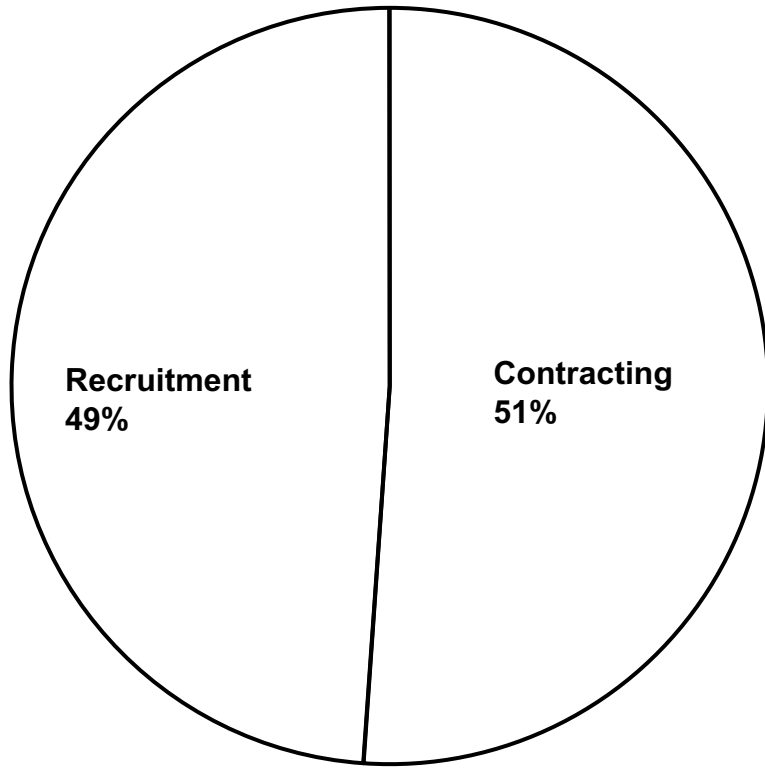


**Adjusted Net Revenue**

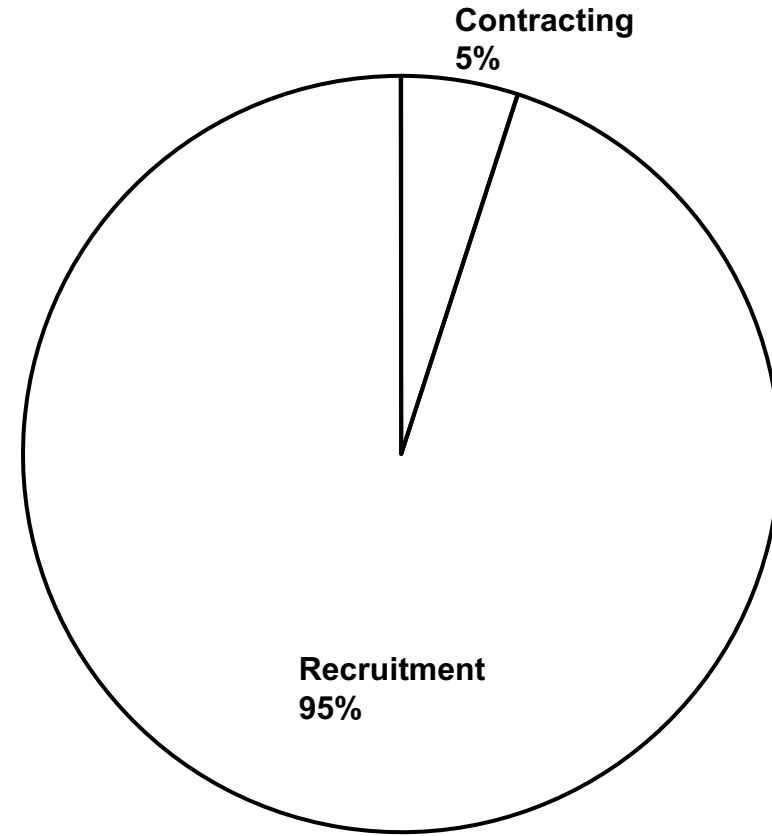


# Q3 2022 RPO Services Split
